What is this product?

Type:	This product is an exchange traded product (non-interest-bearing perpetual, fully collateralized debt instrument).
Objectives:	This product seeks to track the performance of Binance Coin.
Intended Investor:	This product is intended for institutional and Swiss retail investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 1 year. It is designed to form part of a portfolio of investments.
Maturity:	This product is open ended. However, the Manufacturer reserves the right to terminate and redeem the product, at the Manufacturer's sole discretion as well as in certain specified cases, in each case without any further prior consent of the investors, by publishing a Termination Notice (specifying the Redemption Date) in accordance with the General Terms and Conditions.
